- Bachelor's degree (or equivalent), with proven skills in Political Sciences, International Relations, Sociology and International Law
- English language: B2 level (CEFR) or equivalent

1st Year: International Law of Human Rights; Human Rights in International Politics; Constitutional Development and Democratisation; History of International Organisations/ International History of the Balkans/International History of the Middle East; Economic Globalization and Human Rights/ Statistics for Social Science; International Cooperation and Humanitarian Response Operations/Global South and Decolonial Option/Refugee Human Rights Protection; Langue Française et Droits de l'Homme/Lengua Española y Derechos Humanos/Italian as a Second Language.

2nd Year: Social and Financial Sustainability for Small Business/Economics of Inequality; Culture, Society and Human Rights/Religions and Human Rights; Regional Human Rights Systems/European Union Law and Human Rights; Women's Human Rights/Children's Rights/Human Rights and Political Participation; Human Rights and International Justice/Human Rights Practice/Labour and Global Social Justice/Work, Migration and Globalization/History of Genocides; Internship.
