## ENTRY REQUIREMENTS

- Bachelor's degree (or equivalent) in the fields of Management and Administration or related fields that can prove extensive academic skills in the core area of Management as well as proven academic skills in the areas of Accounting and Finance and Economics and Quantitative
- English language: B2 level (CEFR) or equivalent
- GMAT and/or GRE score (preferential)
- English C Level (CEFR) or equivalent (preferential)

## PROGRAMME STRUCTURE

1st Year: from sustainable strategies and business models to organisational structures, from business economics to accounting systems.

2nd year:

Curriculum Smart Manufacturing: Lean Management, Sustainable Manufacturing, Supply Chain, Machine Learning for Operation Management.

Curriculum Marketing and Digital Transformation: Relational Marketing, Economics of Innovation, Digitalisation and Product-service Innovation, Quantitative Methods and Analytics for Marketing.

Curriculum People and Organisation: Talent Management, Diversity and Inclusion, Performance Management and Compensation.

Common modules: internship, elective courses and thesis.
